The applicant agrees to the following: (a) To fill/excavate the premises hereinabove described as evenly as possible. (b) At the end of the such filling/excavating to level and grade such fill. (c) To see to it that the top 16 inches of the fill/excavation shall be of soil free from gravel or broken concrete and that the upper 4 inches thereof shall be of topsoil suitable for growing vegetation. (d) To keep the surface of said filling/excavation free from dust at all times during the filling/ excavating operations and thereafter. (e) To comply with any other conditions which may be imposed by the Board of Trustees upon recommendation of the Inspector. (f) To reimburse the Village of River Hills for any damages or expenses which the Village may necessarily incur by reason of any filling/excavating operation of the applicant, or as a result of any violations or any ordinances respecting same. (g) The entry upon the premises covered by the permit of the Inspector employed by the Village and the compliance with his directions with respect to the manner in which the said filling/ excavating operations are to be conducted, all of which is more specifically authorized in Chapt. 15 of the General Ordinances of the Village of River Hills. # FILLING & EXCAVATING PERMITS

Required to move more than 20 cubic yards per acre of lot. (5 acre lots = 100 cubic yards)

Complete & sign an application form

Excavator/landscaper/owner must provide plans

Disturbing more than an acre of land requires DNR approval.

#### Plans must:

- o Show topography of location
- Show both the existing site & proposed changes
- o Show location of silt fence

#### Where are they going with all of this dirt:

- Will dirt be trucked in or out of this site?
   Lots of trucking (especially in spring) may require a road bond.
- o If it remains on site, where will it be piled?

  Might create a temporary hazard or drainage issue.

### Will they be putting in culverts?

- o Culverts require a permit. (\$110.00)
- Kurt needs to approve installation of culverts.
