# 7. MANOR LANE (LODGEWOOD RD) LIFT STATION ENGINEER'S PRELIMINARY DESIGN REPORT – KURT FREDRICKSON, PUBLIC WORKS SUPERINTENDENT AND MUSTAFA EMIR, CLARK DIETS ENGINEERING

- a. Anna Lieske (8930 N Lodgewood Rd) is concerned about the deterioration of her yard and is this due to the lift station.
  - i. No according to Kurt Fredrickson her deterioration is due to a storm water pipe going underground across her property. Other action will be taken to see what the issue is.
- b. Frank Bryson (8900 N Lodgewood Rd) is wanting to know how the other parts of the sewage system are funded
  - i. Currently all sewer system repairs and maintenance are funded by the annual sewer charge on property owners tax bills
- c. Mehrdad Kazemi (8875 N Lodgewood Rd) opinion is that the lift station is part of a bigger system; therefore, the whole village should pay for it and not just the 20 residents that it affects.
