1. Police department purchase request

Motion by Glaisner/Perry to approve donation of \$4,400 to the police department for new department body armor. Motion carried unanimously.

2. 2017 donation totals

- **a.** \$10,150 received from the 2016 2017 mailing, 4 books sold
- **b.** \$3,650 received from the 2017 2018 mailing as of 12/12/17

3. Money market and checking account balances

- **a.** Money Market \$85,934.27 as of 11/30/17
- **b.** Checking account \$6,413.24 as of 11/30/17
 - **i.** Total \$92,347.51

Motion by Severson/Perry to close the Non-Profit Checking account and transfer the funds to the Money Market account. Motion carried unanimously.

4. Outstanding bills

a. 2017 mailing postage – bill presented from the village for \$287.04

Motion by LaBahn/Perry to approve reimbursement back to the village for mailing postage. Motion carried unanimously.

5. Report by Village Manager

a. Arbor day funding proposal

i. Funding proposal ended in 2017; therefore, a new one is needing to be approved for the next three years.

Motion by Baumgartner/Glaisner to approve \$1,000 per year for 3 years for the expenses of the Committee on the Environments Arbor Day/Tree City event. Motion carried unanimously.

b. Library rehab update

i. Presentation by North Shore Library Foundation President Paul Peterson and North Shore Library President Kurt Glaisner on the current status of the potential upgrades to the library. After discussion it was determined that a written report of how much money the library would need like from the foundation and what it would be used for needs to be presented at a later date.

c. Update from DPW

i. Reports presented in initial packet for review - no questions asked

i. No purchase of the property has been done or plans submitted to any village boards.
