3. PRESENTATION by Tina Wagner Regarding 2019 Health, Dental & Vision Insurance

Tina Wagner presented the following updates

- Current plans are transitional relief and in 2020 the village will be going to community rating.
- 2019 plan will have a 0.43% decrease in premium but will increase the employee portion of their deductible from \$2,000 to \$2,850 for single and from \$4,000 to \$5,700 for family plans.
- The village will switch from two dental plans with UHC to one plan with Delta Dental. This plan will be cheaper then the standard original plan but have the coverage of the original buy up plan.
- Vision will be no longer be with UHC but with Delta Dental.

6. <u>Discussion and Possible Action to Approve RESOLUTION 2018-11 – Approving the Final Resolution</u> <u>Levying Special Assessment Against Benefited Property in the Matter of the Replacement and Installation of a Sewer Pump Lift Station at Manor Lane and Lodgewood Road</u>

Resident Steve Largent, 1005 W Lodgewood Rd

 Does not feel the state statute governing special assessment does not seem to apply because residents are not receiving a special advantage by having this lift station. Feels these residents have a disadvantage.

Resident Rosalie Gellman, 1170 W Lodgewood Ct

- Sent a letter after the October meeting expressing her disapproval of the special assessment. Asks the village to reconsider because the village is getting more of a benefit in the form of money compared to the residents just getting sewer.
- Wishes the whole village would pay for the lift station.

Village Trustee Peter Kingwill comments

- If the village passes this special assessment will they be setting a precedent?

- Concerned the village is setting a bad precedent is they don't pass the special assessment because when some other project comes up later will the residents be upset because they denied special assessing before.

Village Trustee Peggy Russo comment

- Received a breakdown of the \$85,000 engineering costs from Mustafa Emir and reported it would be under budget.

Village Trustee Kurt Glaisner comment

- Throughout other communities that have sewer the resident's maintenance ends at the street so why is the neighborhood having to pay for more than they own.

Village Trustee Bill Walker comment

- In favor of the special assessment because the equipment only benefits these parcels

Village Trustee Chris Noyes comment

- Has had sidewalks and curbs special assessed at previous home and they didn't just benefit him as a homeowner

Motion by Noyes and seconded by Kingwill to approve as submitted; motion carried unanimously.

7. <u>Presentation by Village of Brown Deer regarding proposal for North Shore Library in Brown Deer – Discussion and Possible Action</u>

Brown Deer Village Manger Michael Hall presented

- Brown Deer is constructing a new library and is reaching out to other communities to see if anyone wants to benefit from it by joining Brown Deer in creating a new North Shore library.
- Requesting input from communities before approving or rejecting plan for a new North Shore Library
- Has met with Glendale who asked for additional information.
- Has met with Fox Point who has rejected any future proposal
