ORDINANCE NO. 534

An Ordinance to Amend Chapter 14 of the General Ordinances of the Village of River Hills Relating to the Electrical Code

The Village Board of the Village of River Hills, Milwaukee County, do ordain as follows:

Section I. Subsection 14.07(3) of Chapter 14 Electrical Code of the General Ordinances of the Village of River Hills is hereby amended to read as follows:

Adoption of; Conformity with State and National Electrical Code. The Wisconsin Administrative Electrical Code, Volume 1 Chapter PSC II4 and Volume 2, Wis. Admin. Code Chapter SPS 316, along with the National Electrical Code, and any future additions, amendments or modifications of the same, and supplements thereto, are hereby adopted as the regulations at all times for electrical installation, alteration or repair occurring the installation of electric wiring and systems in the Village. All work, including the placing of wires and other equipment, shall be done in conformity with said State Code and latest supplements thereto, and in such manner as in the judgment of the Electrical Inspector will not be liable to endanger life or cause fire. In the event there is a conflict between the State and National Codes, the State Code shall control.

Section II. Subsection 14.11(1); 14.11(2); and 14.11(3) of Chapter 14 Electrical Code of the General Ordinances of the Village of River Hills is hereby amended to read as follows:

'Section 14.11. INSPECTION FEES. (1) General Charges. The applicable fees for inspecting all electrical equipment or installations shall be those fees set forth in the Village of River Hills Fee Schedule for Electrical Permits as adopted and subject to amendment from time to time by Resolution of the Village Board. The Resolution and the applicable schedule of fees shall be kept on file in the Office of the Village Clerk and will be posted on the village website. (Ord#502,1/16/2008) to wit:

- (2) <u>Additional</u>. An additional fee as set forth in the schedule of fees as adopted and subject to amendment from time to time by Resolution of the Village Board of Twenty five (\$25.00) Dollars shall be charged to and paid by the licensed electrician in the event the said licensee shall fail to obtain a final inspection of any work for which a permit has been issued. The Resolution and the applicable schedule of fees shall be kept on file in the Office of the Village Clerk and will be posted on the village website.
- (3) <u>Administrative Fees</u>. A non-refundable administrative fee <u>as set forth in the schedule of fees as adopted and subject to amendment from time to time by Resolution of the Village Board of \$10.00 shall be paid in addition to the permit fees for each electrical permit. (Ord 480, 1/13/03) The Resolution and the applicable schedule of fees shall be kept on file in the Office of the Village Clerk and will be posted on the village website.'</u>
- **Section III.** If any subsection, section or portions of this article or the sections of this ordinance as enacted hereunder is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portions shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions hereof.
- **Section IV.** All ordinances or parts of ordinances conflicting with the provisions of this ordinance are to such extent repealed.
- **Section V.** This ordinance shall be in full force and effect after its passage and publication as provided by law.
