

NOTICE OF REFERENDUM  
MAPLE DALE-INDIAN HILL SCHOOL DISTRICT  
APRIL 2, 2019

NOTICE IS HEREBY GIVEN, that at an election to be held in the Maple Dale-Indian Hill School District on April 2, 2019, the following proposed Resolution Authorizing School District Budget to Exceed Revenue Limit and Initial Resolution of the School Board will be submitted to a vote of the people:

RESOLUTION NUMBER I

RESOLUTION AUTHORIZING THE SCHOOL  
DISTRICT BUDGET TO EXCEED REVENUE  
LIMIT BY \$980,000 PER YEAR FOR TEN YEARS  
FOR NON-RECURRING PURPOSES

BE IT RESOLVED by the School Board of the Maple Dale-Indian Hill School District, Milwaukee County, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$980,000 per year beginning with the 2019-2020 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of operating expenses.

RESOLUTION NUMBER II

INITIAL RESOLUTION AUTHORIZING  
GENERAL OBLIGATION BONDS IN AN  
AMOUNT NOT TO EXCEED \$16,370,000

BE IT RESOLVED by the School Board of the Maple Dale-Indian Hill School District, Milwaukee County, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$16,370,000 for the public purpose of paying the cost of a District-wide school improvement program consisting of: building systems and infrastructure updates; safety and security upgrades, including secure main entrances; capital maintenance, site improvements, renovations and Americans with Disabilities Act (ADA) accessibility updates; and acquisition of related fixtures and equipment.

The questions will appear on the ballot as follows:

QUESTION 1

“Shall the Maple Dale-Indian Hill School District, Milwaukee County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$980,000 per year beginning with the 2019-2020 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of operating expenses?”

QUESTION 2

“Shall the Maple Dale-Indian Hill School District, Milwaukee County, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$16,370,000 for the public purpose of paying the cost of a District-wide school improvement program consisting of: building systems and infrastructure updates; safety and security upgrades, including secure main entrances; capital maintenance, site improvements, renovations and Americans with Disabilities Act (ADA) accessibility updates; and acquisition of related fixtures and equipment?”

EXPLANATORY STATEMENT AND EFFECT OF VOTE

The referendum election ballot will ask District electors to vote “yes” or “no” on the referendum election questions as set forth above.

A “yes” vote on Question 1 is a vote to authorize the Maple Dale-Indian Hill School District budget to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$980,000 per year beginning with the 2019-2020 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of operating expenses.

A “no” vote on Question 1 is a vote to deny the Maple Dale-Indian Hill School District the authority to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$980,000 per year beginning with the 2019-2020 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of operating expenses.

In the event a majority of the electors voting on Question 1 vote “yes”, the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$980,000 per year beginning with the 2019-2020 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of operating expenses; if a majority vote “no” on Question 1 set forth above, the District will not be so authorized.

A “yes” vote on Question 2 is a vote to approve the borrowing of \$16,370,000 by the Maple Dale-Indian Hill School District through the issuance of general obligation bonds for the purpose of paying the cost of a District-wide school improvement program consisting of: building systems and infrastructure updates; safety and security upgrades, including secure main entrances; capital maintenance, site improvements, renovations and Americans with Disabilities Act (ADA) accessibility updates; and acquisition of related fixtures and equipment.

A “no” vote on Question 2 is a vote to deny the Maple Dale-Indian Hill School District the authority to borrow \$16,370,000 through the issuance of general obligation bonds for the purpose of paying the cost of a District-wide school improvement program consisting of: building systems and infrastructure updates; safety and security upgrades, including secure main entrances; capital maintenance, site improvements, renovations and Americans with Disabilities Act (ADA) accessibility updates; and acquisition of related fixtures and equipment.

In the event a majority of the electors voting on Question 2 vote “yes”, the District will be authorized to undertake the school improvement program described in Question 2 and borrow not in excess of \$16,370,000 therefor; if a majority vote “no” on Question 2 set forth above, the District will not be so authorized.
