

ORDINANCE NO. 501

**An Ordinance To Create Subsection (4) Prohibited Turns of Section 3.05 of Chapter Three (3) of the General Ordinances of the Village of River Hills to Prohibit Left Turns from Northbound Jean Nicolet Road onto Westbound Green Tree Road During Certain Hours in the Village of River Hills.**

The Village Board of the Village of River Hills, Milwaukee County, Wisconsin, do ordain as follows:

**Section I.** Subsection (4) entitled Prohibited Turns of Section 3.05 of Chapter Three (3) of the General Ordinances of the Village of River Hills is hereby created to read as follows:

“(4) Prohibited Turns. In the interest of public safety, vehicles approaching the following intersections, streets or highways shall be prohibited from making the following turning movements and such prohibition shall be posted on official traffic signs where the turn is prohibited.

(a) Left turns are prohibited onto westbound Green Tree Road from northbound Jean Nicolet Road between the hours of 6:30 a.m. and 7:30 a.m. Monday through Friday from the 1st of September to the following 15th of June.”


**Section II.** The penalty and enforcement provisions of Sections 3.09 and 3.10 of Chapter Three (3) of the General Ordinances of the Village of River Hills are hereby made applicable to any violations of this ordinance.

**Section III.** If any subsection, section or portions of this article or the sections of this ordinance as enacted hereunder is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portions shall be deemed a separate, distinct and independent provision and such holdings shall not effect the validity of the remaining portions hereof.

**Section IV.** All ordinances or parts of ordinances conflicting with the provisions of this ordinance are to such extent repealed.

**Section V.** This ordinance shall be in full force and effect after its passage and publication as provided by law.

**Re: Request for Traffic Sign**

I am requesting that the Village Board approve the attached ordinance as it relates to vehicles making left turns, from northbound N. Jean Nicolet Road, to go west on W. Green Tree Road, during specific times, and calendar dates. The ordinance would prohibit vehicles from making the turn between the time frame of 6:30am to 7:30am, Monday through Friday, from September 1 through June 15. This request was generated due to complaints of traffic backing up in the morning, when school is in session at Jean Nicolet High School. By diverting the traffic to the east only, the intersection would be kept clearer, and allow for better traffic flow. An official traffic sign or signs would be placed on the east side of N. Jean Nicolet Road, and the south side of W. Green Tree Road, indicating such. Enforcement of the sign(s) would be governed by sections 3.09 and 3.10 of the Village Ordinances and adopted Wisconsin State Statute 346.33(1)(d) by uniform traffic citation prosecuted in the River Hills Municipal Court. Attorney Dineen has prepared the ordinance for approval and signature. If approved, I would like to have the sign in place by mid to late August, so motorists have a chance to familiarize themselves with it.
