#### TO: BOARD OF COMMISSIONERS OF PUBLIC LANDS

We, the undersigned president and clerk of the Village of River Hills, in the County(les) of Milwaukee, Wisconsin, in accordance with the provisions of Chapter 24 of the Wisconsin Statutes, do hereby make application for a loan of Six Hundred Fifty Eight Thousand Two Hundred Sixty Nine And 00/100 Dollars (\$658,269.00) from the Trust Funds of the State of Wisconsin for the purpose of financing 2019 capital projects.

The loan is to be continued for a term of 10 years from the 15th day of March preceding the date the loan is made. The loan is to be repaid in annual installments, as provided by law, with interest at the rate of 4.25 percent per annum.

We agree to the execution and signing of such certificates of indebtedness as the Board may prepare and submit, all in accordance with Chapter 24, Wisconsin Statutes.

The application is based upon compliance on the part of the Village with the provisions and regulations of the statutes above referred to, as set forth by the following statements which we do hereby certify to be correct and true.

At the aforesaid meeting a resolution was passed by a vote of not less than a majority of the members of the village board approving and authorizing an application to the Board of Commissioners of Public Lands, State of Wisconsin, for a loan of Six Hundred Fifty Eight Thousand Two Hundred Sixty Nine And 00/100 Dollars (\$658,269.00) from the Trust Funds of the State of Wisconsin to the Village of River Hills, in the County(ies) of Milwaukee, Wisconsin, for the purpose of financing 2019 capital projects. That at the same time and place, the village board of the Village of River Hills by a majority vote of the members, adopted a resolution levying upon all the taxable property in the Village, a direct annual tax sufficient in amount to pay the annual installments of principal and interest, as they fall due, all in accordance with Article XI, Sec. 3 of the Constitution and Sec. 24.66(5), Wisconsin Statutes.

A copy of the aforesaid resolutions, certified to by the village clerk, as adopted at the meeting, and as recorded in the minutes of the meeting, accompanies this application.

A statement of the equalized valuation of all the taxable property within the Village of River Hills, certified to by the president and clerk, accompanies this application.
