#### 1. Approval of minutes from the June 17, 2019 meeting.

Motion by C. Meisel and seconded by W. Nielsen to approve; motion carried unanimously.

## 2. Discussion/action on the installation of a fence at the Sarnoski residence, 1907 W County Line Rd.

Homeowner Ms. Sarnoski present and thanked Stephanie for all of her help with the permit.

- Small fence for small dog wood picket fence
- The existing fence will be removed
- The color of the fence will be natural to grey in color
- A sample of the wood and style (3" spacing) 4x4 posts was provided

### 3. Discussion/action on the installation of a utility shed at the Indian Hill School, 1101 W Brown Deer Rd.

- They are going to move the shed 125' away from the proposed location as per the aerial view submitted at the meeting
- All wood, natural color, will move next to the building and will be installed by Home Depot
- Shed will be used for storing lawn mowers and snow blowers
- Skylight on the south side of the roof
- One window on the north side of the shed. No electricity.

Motion by S. Simon and seconded by R. Juehring to approve the project with the revised location as shown on the aerial view; the skylight located on the south side of the roof; and one window on the north side of the shed; motion carried unanimously.
