BOARD OF TRUSTEES MEETING MINUTES Wednesday, October 16, 2019 @ 5:30 pm

1. <u>Roll Call:</u> was answered at 5:30 p.m. by President Anderson, Bill Walker, Peter Kingwill, Christopher Noyes, Peggy Russo, and Kurt Glaisner. Trustee David Fritz was absent and excused. Also present: Village Manager Tammy LaBorde, Public Works Superintendent Randy Groth, and Police Chief Milton Mrozak. Village Attorney Bill Dineen arrived at 6:45 p.m.

2. <u>BUDGET WORKSHOP – 2020 VILLAGE BUDGET</u>

a. Update Regarding Health insurance for 2020

Motion by Kingwill and seconded by Russo to change the capital plan to take out the Range Line Rd replacement for 2020 but still move forward with the culvert replacements; motion carried unanimously.

They will move forward next year with the purchasing of a River Hills property and being the design phase of the three lane expansion which is set to begin in late 2021.

g. Discussion and Possible Action regarding Maintenance Agreement with Milwaukee County for Traffic Light at River Road and Good Hope Road

The Police Chief, Public Works Superintendent, Village Engineer and Manager met with Milwaukee County who has proposed a cost to be split between them and the Village or River Hills for ongoing maintenance of a traffic light. Once completed the Village of River Hills would pay one-half the cost to maintain the traffic light and also pay for the electricity.
