# PLAN COMMISSION MINUTES Tuesday, September 29, 2020 @ 4:00 pm

This meeting was a virtual meeting through Zoom – Meeting code 849-3988-5187

#### 1. Roll Call.

Joe Murray of Ehlers & Associates went through the 37-page TID No. 1 Project Plan dated September 9, 2020. The TID would be created as a Rehabilitation/Conservation District containing approximately 53.4 acres located on the north side of W. Brown Deer Road commonly referred to as "the Eder Property".
