Data from the same media outlets, shows at 9:35 p.m., River Hills reported 100% of the votes, for both precincts from the Village had case votes, equaling the same total of votes as at 8:35 p.m., and the same distribution per candidate, as demonstrated on Exhibit B, attached hereto and incorporated herein.
