
LYNDEN SCULPTURE GARDEN MEMBERSHIP

The goal is to prevent destruction to the natural habitat, diminish the effects of erosion to river and stream banks, work with contractors who are familiar with regulations for the removal of invasive plants/shrubs/trees and work with native plantings, and to protect property owners from unintentionally violating regulations and ordinances.

A quick site visit or conversation with you or your contractor will usually address these issues.
