ORDINANCE NO. 564

An Ordinance To Create Section 3.055 of Chapter Three (3) of the General Ordinances of the Village of River Hills Regarding Weight Limits, Heavy Traffic Routes and No Trucking on Certain Roads in the Village of River Hills.

The Village Board of the Village of River Hills, Milwaukee County, Wisconsin, do ordain as follows:

Section I. Section 3.055 of Chapter Three (3) of the General Ordinances of the Village of River Hills is hereby created to read as follows:

"3.055. Weight limits and Heavy traffic routes.

- (1) <u>Class "A" highways</u>. Brown Deer Road, Good Hope Road, Green Bay Road and Interstate Highway I 43 are hereby designated Class "A" highways, and the weight limitations established in § 348.15, Wis. Stats., shall be applicable thereto.
- (2) <u>Class "B" highways</u>. All streets except those set out in Subsection A of this section are hereby designated Class "B" highways, and the weight limitations established in § 348.16, Wis. Stats., shall be applicable thereto.

(3) No trucking.

- (a) No vehicle which is not equipped with pneumatic tires or has a combined vehicle load weight exceeding 8,000 pounds, except a motor bus, shall be operated on West Bradley Road from the intersection of West Bradley Road and North Green Bay Road to the intersection of West Bradley Road and North Range Line Road except for the purpose of picking up or delivering materials (including refuse or recyclables), supplies or commodities, which pickups or deliveries originate from or terminate within the Village. Authorized emergency vehicles and state, county and municipality-owned vehicles are exempt from this subsection. In no event shall the weight of the vehicle and load in such case exceed the limitations of § 348.15 or 348.16, Wis. Stats., pertaining to Class "A" or "B" highways.
- (b) The provisions of this section do not apply to any street if seasonal weight restrictions have been imposed under § 348.17, Wis. Stats.
- (4) <u>Heavy traffic routes</u>. The highways designated at Class "A" highways are hereby designated as heavy traffic routes."

Section II. The penalty and enforcement provisions of Sections 3.09 and 3.10 of Chapter Three (3) of the General Ordinances of the Village of River Hills are hereby made applicable to any violations of this ordinance.

Section III. If any subsection, section or portions of this article or the sections of this ordinance as enacted hereunder is for any reason held invalid or unconstitutional by any court of competent

jurisdiction, such portions shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions hereof.

<u>Section IV.</u> All ordinances or parts of ordinances conflicting with the provisions of this ordinance are to such extent repealed.

<u>Section V.</u> This ordinance shall be in full force and effect after its passage and publication as provided by law.
