

# Village of River Hills Tax Levy Referendum

#### What It Means to You

**On November 8, 2022** you will be asked to vote on whether the Village of River Hills should be allowed to exceed its tax levy limit by a fixed amount for the next 5 years.

The purpose of exceeding the levy limit is to maintain the existing level of services provided by our Police, Public Works and Administration. To maintain the current level of services to our residents, the Village will need more revenue.

Since 2010, the State mandates constraints on the Village's levy limit, which is the amount by which the Village can increase its annual budget. The Village was only able to increase the 2022 budget by \$8,200 and the 2023 budget is limited to an increase of \$20,197. This increase is well below most inflationary factors. The actual increase in fixed costs for the 2023 budget is estimated at over \$250,000. If approved, the referendum would allow the Village to exceed its tax levy limit by \$300,000 in each of the next five years, which the Village Board believes is sufficient to close the budget deficit in each of those years.

The Village is only permitted to exceed its levy limit if approved by the majority of the voters via a referendum.

This referendum is asking for your support and permission to increase taxes to finance the current level of Village services.

#### **IMPACT ON TAXES if the Referendum Passes**

Your annual property taxes will increase by \$57.23 per \$100,000 of property value.

### **CONSEQUENCES of a Failed Referendum**

- POLICE Loss of a police officer position Would result in –
   Inability to staff 2 officers per shift in a 24-hour period leading to
   Single officer shifts, a less safe community, less traffic enforcement,
   less traffic violation revenue, increase in response times, higher
   overtime costs. Reduced programs Home checks, traffic
   enforcement, school traffic and patrols.
- <u>PUBLIC WORKS</u> <u>Loss of one position</u> Reduction in services provided such as brush collection, tree maintenance, landscape maintenance, roadside mowing and special projects.
- **ADMINISTRATION** There are 2 employees in this department the Village Manager/Clerk/Treasurer and Deputy Clerk/Treasurer.
