ORDINANCE NO. 566

An Ordinance To Amend Subsection 3.055 (3) of Chapter Three (3) of the General Ordinances of the Village of River Hills Regarding Weight Limits and No Trucking on Range Line Road in the Village of River Hills.

The Village Board of the Village of River Hills, Milwaukee County, Wisconsin, do ordain as follows:

Section I. Subsection 3.055 (3) of Chapter Three (3) of the General Ordinances of the Village of River Hills is hereby amended to read as follows:

"3.055. Weight limits and Heavy traffic routes.

(3) No trucking.

- (a) North Range Line Road. No vehicle which is not equipped with pneumatic tires or has a combined vehicle load weight exceeding 8,000 pounds, except a motor bus, shall be operated on North Range Line Road within the limits of the Village, except for the purpose of picking up or delivering materials (including refuse or recyclables), supplies or commodities, which pickups or deliveries originate from or terminate within the Village. Authorized emergency vehicles and state, county and municipality-owned vehicles are exempt from this subsection. In no event shall the weight of the vehicle and load in such case exceed the limitations of § 348.15 or 348.16, Wis. Stats., pertaining to Class "A" or "B" highways.
- (b) West Bradley Road. No vehicle which is not equipped with pneumatic tires or has a combined vehicle load weight exceeding 8,000 pounds, except a motor bus, shall be operated on West Bradley Road from the intersection of West Bradley Road and North Green Bay Road to the intersection of West Bradley Road and North Range Line Road except for the purpose of picking up or delivering materials (including refuse or recyclables), supplies or commodities, which pickups or deliveries originate from or terminate within the Village. Authorized emergency vehicles and state, county and municipality-owned vehicles are exempt from this subsection. In no event shall the weight of the vehicle and load in such case exceed the limitations of § 348.15 or 348.16, Wis. Stats., pertaining to Class "A" or "B" highways.
- (c) The provisions of this section do not apply to any street if seasonal weight restrictions have been imposed under § 348.17, Wis. Stats."

Section II. The penalty and enforcement provisions of Sections 3.09 and 3.10 of Chapter Three (3) of the General Ordinances of the Village of River Hills are hereby made applicable to any violations of this ordinance.

Section III. If any subsection, section or portions of this article or the sections of this ordinance as enacted hereunder is for any reason held invalid or unconstitutional by any court of competent

jurisdiction, such portions shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions hereof.

<u>Section IV.</u> All ordinances or parts of ordinances conflicting with the provisions of this ordinance are to such extent repealed.

 $\underline{\textbf{Section V.}}$ This ordinance shall be in full force and effect after its passage and publication as provided by law.
