# BOARD OF TRUSTEES MEETING MINUTES Village Hall, Monday, November 21, 2022 @ 4:00 pm

This meeting was an in person and virtual meeting through Zoom – Access code 893-1047-0003

- <u>ROLL CALL</u> Roll call was answered at 4:00 pm by President Chris Noyes, Trustee Jamie Evans, Trustee David Fritz, Trustee Kurt Glaisner, Trustee Jon Isaacson, and Trustee Peggy Russo all in person. Trustee Bill Walker was absent and excused. Also present in person: Village Attorney Bill Dineen, Chief Milt Mrozak, Public Works Superintendent Craig Schroeder, Attorney Alan Marcuvitz, Village Engineer Mustafa Emir, Village Manager Tammy LaBorde, and Deputy Clerk/Treasurer Stacie Nelson.
- 2. PUBLIC HEARING to Amend the Village Comprehensive Plan, Change the Future Land Use Map, Establish Planned Unit Development Residential Overlay District, and re-zone Lot 1 and Lot 2 of CSM 9392 for property on West Brown Deer Road

A redline copy was included to review the proposed changes. The Plan Commission recommended that the Village Board approve.

Motion by Fritz, seconded by Russo to open the Public Hearing at 4:02pm; motion carried unanimously. There were no comments. The notice for the public hearing was published twice as legally required. The Board received a copy of the hearing notice, that included notice that persons could attend the hearing virtually via a Zoom link.

Motion by Glaisner, seconded by Evans to close the Public Hearing at 4:03pm; motion carried unanimously.

### 3. PUBLIC HEARING on the 2023 Budget

LaBorde stated that a copy of the Budget was distributed and posted to the website. One change was made to the amount for MADACC, otherwise no changes. The notice for the hearing was published and a copy of the notice was in the packet. The notice of hearing for the Budget did not include a notice that persons could attend virtually via Zoom.

Motion by Fritz, seconded by Russo to open the Public Hearing at 4:03pm; motion carried unanimously. There were no comments.

Motion by Russo, seconded by Isaacson to close the Public Hearing at 4:05pm; motion carried unanimously.

# 4. Discussion and Action to Approve RESOLUTION 2022-19 to Adopt the 2023 Annual Budget and Establish the 2022 Tax Levy Utilizing the Tax Levy Allowable Increase

Motion by Fritz, seconded by Glaisner to Approve Resolution No. 2022-19 to Adopt the 2023 Annual Budget and Establish the 2022 Tax Levy Utilizing the Tax Levy Allowable plus an additional \$300,000 as approved by the voters of the Village in a Referendum which passed on November 8, 2022, setting the levy at \$3,338,157 and tax rate at \$7.33 for the village; motion carried unanimously.

Discussion Regarding the Village Website at the February meeting

16. Continued Discussion and Possible Action to Approve Use of ARPA Funds for Solar Panel Installation or Stormwater Project

Discussion regarding utilizing the ARPA funds for solar. Andrew Holmstrom from Arch Solar was present for this item. WE will buy back electricity at 4.2 cents per kw hour. The Village is currently paying 13 cents per kw hour. There is no storage system proposed. Supt. Schroeder plans to look at combining the 3 meters that we have to one as suggested by Mr. Holmstrom. The project will qualify for Focus on Energy Incentives in the year following installation. The total project cost is \$153,461 with Focus on Energy incentives of \$54,351, which yields a net cost of \$99,110. There is a balance of \$126,911.96 currently available. The other option would be to use the funds and apply them to the culvert repair on Range Line Road. There was discussion as to continuing to borrow for the culvert project.

Motion by Fritz, seconded by Russo to approve the use of ARPA funds for Solar Panel Installation on Village Hall and the DPW Building; motion carried 5-aye, 1-abstain (Glaisner).

# 17. Discussion and Possible Action Regarding No Left Turn Sign on Green Tree Road at Jean Nicolet Road

Due to construction taking place along I-43 and in Glendale, a request was made to temporarily remove the left turn sign. A notice will be sent out to the residents along Green Tree Road about the increase in traffic during those times.

Motion by Fritz, seconded by Russo to direct DPW to temporarily remove the "No Left Turn" sign as they deem appropriate during the times as noted on the construction map and then return it once construction is completed – February to October 2023 and June to November 2024; motion carried unanimously.

President Noyes stated that Mayor Kennedy in Glendale had raised this issue recently. Mayor Kennedy asked all communities to look at the possibility of placing a referendum on the spring ballot to find out what their communities would like to do related to police consolidation. The consensus of the Board determined that they are not interested.

#### a. Financial Report for October 2022

LaBorde noted that the Village has completed 83% of the year. There are a few accounts that have exceeded budget but have revenues to offset. All of the funds are on track.

#### a. Summary Report

b. Discussion and Possible Action to Approve RESOLUTION 2022-24 to Carry Over Funds from 2022 to 2023 for Firearms

Chief Mrozak presented the summary report. It looks like they will be finishing up on the Green Bay Road and Brown Deer Road projects. The department has been monitoring Range Line Road and issuing citations. Mequon has now received requests to lower their speed limit to 25mph.

Chief Mrozak stated that he would like to carryover funds from 2022 to 2023 in order to move forward with purchasing weapons for the department.

Motion by Isaacson, seconded by Glaisner to approve Resolution 2022-24 to Carry Over Funds from 2022 to 2023 for firearms; motion carried unanimously.

# 13. RESOLUTION 2022-25 to Approve the 2023 North Shore Environmental Health Consortium Fee Increase.

This item was removed from the Consent Agenda – Item #13.f., and taken up at this time. This is just a annual request to update their fees.

Motion by Fritz, seconded by Russo to Approve Resolution 2022-25 the 2023 North Shore Environmental Health Consortium Fee Increase; motion carried unanimously.

### **25. REPORT OF PUBLIC WORKS**

a. Discussion and Possible Action Regarding ORDINANCE NO. 571 to Removal of Ash Trees within 50 feet of the right-of-way, communication lines, and property boundaries

#### b. Discussion Regarding Range Line Bridge

Supt. Schroeder presented information regarding the issue with dead ash trees throughout the Village. The ordinance will be reworked and brought back to the Board in February.

Supt Schroeder noted that the mortar is beginning to crumble on the Range Line Road bridge. The Village needs to start making a plan looking at annual repairs or replacement. Federal funding cannot be used for the bridge as it has landmark status. The federal funding is based on a 80/20 split. There are several options available – delist the bridge as a landmark to qualify for federal funding, rehab what is there, apply for a matching grant through TAP for a 50/50 split. He will start working on a plan for the bridge and will work with Mustafa.

# 26. REPORT ON COMMUNITY GATHERINGS

### a. Update

Trustee Russo signed the contract for September 14<sup>th</sup>. She also has a sponsor for the event. She will be going to the Foundation to ask for funding of \$1,000 matching for the Evening at the Audubon. She has someone who is interested in sponsoring the Lynden membership for 2023.

### 27. REPORT OF THE NORTH SHORE FIRE DEPARTMENT

The North Shore Fire Department has several resolutions that will need the Village to take action before the end of the year. The Board will meet on Wednesday, December 7<sup>th</sup> at 4pm to address those resolutions.

Trustee Glaisner stated that statistics for October were distributed. He has no update regarding fundraising for the Library.
